Submission on Draft Terms of Reference Attorney-General's Department Reference on Copyright to the Australian Law Reform Commission

CICI welcomes the release of the Draft Terms of Reference¹ and appreciates the opportunity to comment.

CICI is a special interest group of cultural institutions concerned about the balance of content regulation. Its work in the area of copyright practice includes the publication of *Statement of Principles regarding* the use of section 200AB of the Copyright Act (1968): an industry standard and user guide for the cultural sector (September 2010).²

As cultural institutions, CICI members serve an important function in relation to the first three of the four points in the preamble of the Draft Terms of Reference. They undertake activities, often mandated by their enabling legislation, offering the public benefits of:

- promoting the production of original copyright materials;
- fostering creativity and innovation and promoting cultural development; and
- opportunities for innovation leading to national economic and cultural development created by the emergence of new digital technologies.

CICI is pleased that the Draft Terms of Reference covers "amongst other things", the creation and delivery of new products and services and the non-commercial use of copyright material on the internet. CICI understands this to cover a broad range of uses, with particular emphasis on public uses. This is pertinent to the access functions of cultural institutions which are often hindered by copyright and related issues, including but not limited to perpetual copyright in unpublished material and the 'orphan works' problem, which are not adequately addressed by existing exceptions.
